

# AMGEN Privacy Statement for HealthCare Professionals

## 1. In what instances does Amgen collect personal information about you?

- When you interact with Amgen staff members or our representatives acting on our behalf in Algeria, including Alpharep Pharma (hereinafter referred to “Amgen”).
- When you participate in, or request to be considered for Amgen-related activities, such as clinical trials, advisory boards, consultancy or you have any other contractual relationship with Amgen.
- When you register for an Amgen-sponsored event (including online events).
- When you interact with Amgen or third-party websites or mobile applications (“Apps”) where you have provided personal information in accordance with their respective privacy policies.
- When you contact us for medical information, safety, or quality issues, and
- When we send you commercial marketing and medical communications campaigns.

In addition, Amgen is regularly provided with professional information about HealthCare Professionals from a third-party service provider. Amgen takes steps to ensure that the information it receives has been collected and transferred in compliance with applicable privacy laws.

In Algeria, Alpharep Pharma may collect HealthCare Professional data in connection with Amgen activities, and the information is entered into Amgen systems.

## 2. Why does Amgen process personal information about you?

Amgen may process personal information about you on one of the following grounds: A) for legitimate business purposes, (B) where you have given your consent, (C) to comply with Amgen’s legal and regulatory obligations, and (D) in connection with a contract under which you perform a task.

### Comply with local applicable legal and regulatory obligations

- Reporting of adverse events for pharmacovigilance and product complain
- Clinical Trials
- Provision of medical information: response to requests for medical information and “Dear Doctor Letter”
- Transparency in the event of a provision provided for by local legislation.
- Tax obligations

### Consent

- Participation in surveys and online services or applications
- Consent granted to our third-party service providers
- Where applicable Consent granted for communication of information (e.g. via email) promoting Amgen products and services, information and invitations to events or conferences organized by Amgen or in which Amgen participates, etc.
- Transparency in the event where transparency is not local legal requirement

### 3. What kind of personal information do we process?

Depending on the purposes for which personal information is collected, Amgen may process:

- Your name
- Your contact information such as address, email, or telephone number
- Your curriculum vitae and professional information such as areas of specialization
- Your past collaborations with Amgen
- Dates and brief summary of interactions with Amgen’s sales representatives or medical staff
- Professional registration number
- Professional and interaction preferences, interest and speciality, and
- Financial and banking information, but only if necessary to pay you for services or reimburse your expenses.

Amgen uses your personal information to better understand your professional interests and tailor our interactions with you. This helps us provide relevant content, products, and services that match your needs and preferences. Here’s how we do this:

- We analyze your interests, specialty, and preferences to group you with similar healthcare professionals.
- Based on this, we customize the content, communication formats, and offers we share with you.
- Our goal is to make our interactions more relevant and valuable for your professional needs.

This processing relies on legitimate interests to maintain a strong and meaningful relationship with you, ensuring our communications and offerings are well-suited to your profile.

### 4. Who can access personal information about you?

Depending on the purposes for which personal information is collected, such information may be accessed by:

- Authorized staff from Amgen or its representatives, acting on Amgen’s behalf, including Alpharep (as a service provider acting under Amgen’s instructions), subject to applicable privacy laws.
- Regulatory authorities and ethics committees or other third parties pursuant to applicable laws.
- Third parties processing personal information as a data processor under Amgen’s instruction (for example, a travel service or a clinical research organization).
- Third parties with which Amgen collaborates (for example distributors, other members of the healthcare and pharmaceutical industry), but only after taking reasonable steps to ensure that we can share such information in compliance with applicable privacy laws and
- Potential acquirers and other stakeholders in the event of a merger, legal restructuring operation such as, acquisition, joint venture, etc.

**5. Where is personal information about you being processed?**

Amgen is a multi-national company headquartered in the United States. Amgen maintains data centres around the world, including in the European Union and the United States. Amgen may process personal information in global databases that can be accessed by authorised Amgen personnel worldwide. Transfers outside of your local country are made in accordance with applicable privacy laws. Transfers of personal information among Amgen and its group entities follow applicable laws and (if applicable) our European or any other relevant Binding Corporate Rules (BCRs). - The ground on which the data are being collected: e.g. in case of consent, you can revoke it at any time.
- Mandatory retention periods provided by contractual and regulatory requirements.
